Mr. Rogers advised the Board that Sherrie Lacrimosa will be in a training class Monday October 13th for Technical Report Writing.


Chairman, Ronnie Morrow requested to order a flag for our department.

VII. Executive Session:


There was no need to go into Executive Session.
